HOW TO APPLY:

- **Step 1** Complete a FACTS Grant & Aid Application at https://online.factsmgt.com/signin/3XL55. Note the following:
 - Only on-line applications will be accepted
 - FACTS Grant & Aid charges a \$35 processing fee
 - You must submit your 2022 tax return (all pages) and all your 2022 W-2's
 - If you unable to upload your supporting documents you can send by fax to 866.315.9264 or by mail: FACTS Grant & Aid Assessment, P.O. Box 82524, Lincoln, NE 68501-2524
 - For assistance completing your application, you may contact FACTS by phone at 866.441.4637.
 - Completion of the FACTS application does not guarantee an award.
- **Step 2** Complete your church application form, if you are applying for Financial Assistance from Kettering SDA or Centerville SDA. Check with your church office or website for a copy of their application.

Your FACTS Grant & Aid online Application STATUS MUST SHOW COMPLETED before you are considered for any Financial Assistance.

Your school billing account must be <u>paid in full by May 31</u> in order to be considered for Financial Assistance for the New School Year.

You will be notified by email on or before July 3, 2023 of the results of your application.
